19. Describe incident and action taken: <u>I RESPONDED TO ASSIST OFFICER SOUTHERN IN REFERENCE TO A SUBJECT WHO HAD STRUCK A LIGHT POLE AND FLED ON FOOT. UPON MY ARRIVAL I WAS ADVISED THAT THE WHITE MALE DRIVER HAD RAN BEHIND 1407 UNION ROAD. I DEPLOYED K-9 VADER IN THE AREA OF THE DRIVERS LAST KNOWN LOCATION. UPON DEPLOYING K-9 VADER HE IMMEDIATELY NOTICE A STRONG ODOR AND BEGAN TO TRACK SOUTH PARRELL TO UNION ROAD UNTIL REACHING WELLONS DRIVE VADER CONTINUED TO TRACK ALONG THE SHOULDER UNTILL REACHING KELL STREET.. ONCE REACHING KELLY STREET VADER TURNED TO CONTINUE TRACKING ALONG KELLY UNTIL HE REACHED GOLF COURSE DRIVE. SHORTLY BEFORE REACHING GOLFCOURSE I WAS ADVISED THAT THE SUSPECT HAD STOPPED AT 1262 GOLF COURSE DRIVE ASKING FOR HELP. VADER CONTINUED TO TRACK ACROSS STEVENS STREET TO A POWER SUBSTATION ACROSS FROM FERGUESON PARK. VADER CONTINUED TRACKING ALONG A FENCE LINE UTILL REACHING THE TENNIS COURTS OF FERGUSON PARK UNTIL REACHING GOLF COURSE DRIVE. ONCE REACHING THE REAR ENTRANCE OF CITY GOLF COURSE WHERE HE CONTINUED TRACKING . VADER CONTINUED TO TRACK ACROSS AN ASPHALT BRIDGE. ONCE VADER CROSSED THE BRIDGE HE CONTINUED TO TRACK ACROSS THE GOLF COURSE THROUGH THE SHORT GRASS AND THE ASHPHALT OF THE GOLF CART PATH. AFTER APPROXIMATELY 200 YARDS VADER APPEARED TO BEGIN TO AIR SCENT IN THE AREA OF THE MAINTAINCE BUILDING. VADER THEN MADE AN IMMEDIATE LEFT TURN AND STARTED TRACKING THROUGH A SMALL WOODLINE AND INTO A CLEARING. ONCE VADER ENTERED THE CLEARING I OBSERVED THE TROOPER LEE WITH THE SUSPECT IN CUSTODTY APPROXIMATELY 50 YARDS DIRECTLY AHEAD OF K-9 VADER. TIMOTHY WAYNE FOWLER WAS ARRESTED AND CHARGED WITH D.W.I, HIT AND RUN AND RESIST DELAY AND OBSTRUCT.</u>

19. Describe incident and action taken: <u>I RESPONDED TO ASSIST OFFICER'S HUNTER IN REFERENCE TO A POSSIBLE B&E SUSPECT THAT MAY BE HIDING IN THER CRAWL SPACE OF 1474 BRADFORD HEIGHTS ROAD. UPON MY ARRIVAL I WAS ADVISED THAT THE HOME OWNDER A MR. ODOM HAD STATED THAT HE HAD SEEN A BLACK MALE START TO EXIT THE CRAWL SPACE OF HIS RESIDENCE.AND HAD REQUESTED A K-9 TO SEARCH THE CRAWAL SPACE OF HIS RESIDENCE FOR THE POSSIBLE SUSPECT. BEFORE DEPLOYING MY K-9 I ISSUED THREE WARNINGS TO ALLOW ANY POSSIBLE SUSPECTS TO EXIT THE RESIDENCE. AFTER MY FINAL COMMANDS I DEPLOYED K-9 VADER AND COMMANDED HIM TO SEARCH AND APPREHEND ANYONE WHO MAY BE HIDEING INSIDE . UPON DEPLOYING K-9 VADER HE BEGAN TO SEARCH THE CRAWL SPACE. AFTER GOING OUT APPRAXIMATELY 20 FEET HE RETURNED AND BEGAN TO SCRATCH THE INSULATION TO THE RIGHT OF THE DOORWAY. I THEN OBSERVED K-9 VADER GRAB WHAT APPEARED TO BE A BLACK LEATHER CASE. UNSURE OF THE CONTENTS I COMMANDED K-9 VADER TO RELASE I THEN REALIZED TO BE A SHAVING BAG. I THEN OPENED THE CASE AND OBSERVED WHAT APPEARED TO BE A CLEAR PLASTIC BAG OF WHIT POWDER.THROUGH MY TRAINING AND EXPERINCE I BELIEVED THIS TO BE COCAINE. I THEN HANDED THE BAG AND IT'S ENTIRE CONTENTS TO SGT. V.G. JOHNSON. UPON FURTER INSPECTION OF THE CASE A TOTAL OF 90 GRAMS OF POWDER AND CRACK COCAINE WERE LOCATED. MR. ODOM WAS THEN DETAINED AND BASED ON THE FIND BY K-9 VADER OFFICER D.K.HUNTER WAS ABLE TO SECURE A SEARCH WARRANT FOR THE RESSIDENCE. UPON EXECUTING THE SEARCH WARRANT THE FOLLOWING CONTRABAND WAS LOCATED ; \$5,740, 34.4 GRAMS OF COCAINE, 0.5 OUNCES OF MARIJUANA AND VARIOUS PARAPHERNALIA.</u>					

MR. EDWARD ODOM WAS CHARGED WITH TWO COUNTS OF LEVEL TWO TRAFFICKING COCAINE, ONE COUNT OF PWIMSD COCAINE, TWO COUNTS OF MANUFACTURE COCAINE ONE COUNT OF MAINTAIN A VEH/DWELL/PLACE CS (F), ONE COUNT OF POSS. DRUG PARAPHERNALIA AND ONE COUNT OF MISD. POSS. OF MARIJUANA. 5- FELONY CHARGES AND 2 MISDMEANOR CHARGES. 250,000 SECURED BOND.

MRS. VALERIE TAYLOR WAS CHARGED WITH ONE COUNT OF LEVEL TWO TRAFFICKING COCAINE AND ONE COUNT OF PWISD COCAINE. 100.000 SECURED BOND.

19. Describe incident and action taken: <u>ON 02/20/08 AT APPROXIMATELY 2104 HOURS I WAS DISPATCHED TO 2525 COURT DRIVE IN REFERENCE TO A STABBING. WHILE ENROUTE I WAS ADVISED BY OFFICER M.A. LEWIS THAT A HISPANIC MALE HAD STABBED TWO NURES AND FLED THE HOSPITAL ON FOOT. UPON MY ARRIVAL I SPOKE WITH HOSPITAL PERSONEL AND WAS ADVISED THAT TWO GASTON MEMORIAL EMPLOYEES HAD BEEN STABBED IN THE NECK AND HEAD BY A PATIENT WHO HAD PREVIOUSLY BEEN ADMITTED TO THE PYHCIATRIC WARD. WHILE SPEAKING TO OFFICER LEWIS I WAS ADVISED THAT ONE OF THE VICTIMS HAD SERIOUS INJURIES FROM BEING STABBED IN THE CAROTID ARTIERY AND HAD LOST A LARGE AMOUNT OF BLOOD. I WAS ALSO ADVISED THAT THE HISPANIC MALE HAD ALSO SUSTAINED A SIGNIFAGANT CUT TO HIS HAND DURING THE ASSAULT. AFTER SPEAKING WITH HOSPITAL SECURITY I WAS ADVISED THAT THE SUSPECT WAS LAST SEEN RUNNING NORTH ON TE SIDEWALK AFTER HE HAD EXITED THE FRONT ENTRANCE TO THE EMERGENCY ROOM. I THEN DEPOLYED K-9 VADER IN THE AREA WHERE THE SUSPECT HAD LAST BEEN SEEN. VADER IMMEADIATELY NOTICED A STRONG ODER ON THE SIDE WALK AND STARTED TO TRACK NORTH ON THE CONCRETE. AFTER APPROXIMATELY 25 YARDS VADER ENCOUNTERED A SMALL SET OF CONCRETE STEPS AND CONTINUED TRACKING DOWN THE STEPS AND ACROSS THE ASPHALT ENTRANCE TO A PV.A AFTER CROSSING THE ASHPALT VADER CONTINUED TRACKING VERY HARD ON A SECOND SIDEWALK UNTIL REACHING A PARKING LOT. ONCE VADER REACHED THE ASHPALT PARKING LOT HE COONTIUED TRACKING NORTH ALONG THE EDGE OF THE PARKING LOT. VADER THEN EXITED THE PARKING LOT BY CROSSING THROUGH A SMALL LINE OF SHRUBBREY. I THEN COMMMANDED VADER TO STOP BECAUSE OF ONCOMING TRAFFIC. AFTER ALLOWING A VEHICLE TO PASS.VADER CONTINUED TRACKING NORTH ACROSS A SECOND ASHPALT STREET. ONCE</u>					

VADER CROSSED THE ASPHALT STREET HE CONTINUED TO TRACK NORTH ON A SMALL HILL CONSISTING OF SHORT GRASS. AFTER APPROXIMATLY 20 YARDS VADER MADE AN IMMEDIATE LEFT TURN AND BEGAN TO TRACK WEST INTO A SMALL WOODED AREA.. ONCE VADER ENTERED THE WOODS HE BEGAN TO TRACK VERY HARD THROUGH HEAVY BRUSH AND VEGATATION.. VADER CONTINUED TO TRACK FOR APPROXIMATELY 100 YARDS BEFORE MAKING A HARD RIGHT TURN TO TRACK NORTH. FOR ANOTHER 25 YARDS UNTIL EXITING THE WOODS ONTO THE SOUTH SIDE OF COURT DRIVE. AFTER EXITING THE WOODS VADER MADE A LEFT TURN AND BEGAN TO TRACK WEST FOR APPROXIMATELY 100 YARDS. VADER MADE A HARD TURN AND CONTINUED TRACKING SOUTH EAST INTO A SMALL CLEARING AFTER WHERE HE CONTINUED TRACKING FOR APPROXIMATELY 50 YARDS UNTIL ENTERING THE WOODS FOR A SECOND TIME.

27. Continuation Synopsis: ON 02/20/08 AT APPROXIMATELY 2104 HOURS I WAS DISPATCHED TO 2525 COURT DRIVE IN REFERENCE TO A STABBING. WHILE ENROUTE I WAS ADVISED BY OFFICER M.A. LEWIS THAT A HISPANIC MALE HAD STABBED TWO NURES AND FLED THE HOSPITAL ON FOOT. UPON MY ARRIVAL I SPOKE WITH HOSPITAL PERSONEL AND WAS ADVISED THAT TWO GASTON MEMORIAL EMPLOYEES HAD BEEN STABBED IN THE NECK AND HEAD BY A PATIENT WHO HAD PREVIOUSLY BEEN ADMITTED TO THE PYHCIATRIC WARD. WHILE SPEAKING TO OFFICER LEWIS I WAS ADVISED THAT ONE OF THE VICTIMS HAD SERIOUS INJURIES FROM BEING STABBED IN THE CAROTID ARTIERY AND HAD LOST A LARGE AMOUNT OF BLOOD. I WAS ALSO ADVISED THAT THE HISPANIC MALE HAD ALSO SUSTAINED A SIGNIFAGANT CUT TO HIS HAND DURING THE ASSAULT. AFTER SPEAKING WITH HOSPITAL SECURITY I WAS ADVISED THAT THE SUSPECT WAS LAST SEEN RUNNING NORTH ON TE SIDEWALK AFTER HE HAD EXITED THE FRONT ENTRANCE TO THE EMERGENCY ROOM. I THEN DEPOLYED K-9 VADER IN THE AREA WHERE THE SUSPECT HAD LAST BEEN SEEN. VADER IMMEADIATELY NOTICED A STRONG ODER ON THE SIDE WALK AND STARTED TO TRACK NORTH ON THE CONCRETE. ONCE VADER CROSSED THE ASHPALT STREET HE CONTINUED TO TRACK NORTH ON A SMALL HILL CONSISTING OF SHORT GRASS. AFTER APPROXIMATLY 20 YARDS VADER MADE AN IMMEADIATE LEFT TURN AND BEGAN TO TRACK WEST INTO A SMALL WOODED AREA.. ONCE VADER ENTERED THE WOODS HE BEGAN TO TRACK VERY HARD THROUGH HEAVY BRUSH AND VEGATATION.. VADER CONTINUED TO TRACK FOR APPROXIMATELY 100 YARDS BEFORE MAKING A HARD RIGHT TURN TO TRACK NORTH. FOR ANOTHER 25 YARDS UNTIL EXITING THE WOODS ONTO THE SOUTH SIDE OF COURT DRIVE. AFTER EXITING THE WOODS VADER MADE A LEFT TURN AND BEGAN TO TRACK WEST FOR APPROXIMATELY 100 YARDS.
